# Luikart Trophy Deed of Gift

March 21, 1998

This Deed of Gift will supersede the original Deed dated November 14 1969, signed by Ralph Luikart II.

Know all men by these presents that I, Ralph Luikart II of Santa Barbara, California as an expression of my appreciation of the fellowship and sheer sport of sailing at the

Santa Barbara Yacht Club

do hereby rededicate the

Luikart Perpetual Trophy of solid silver especially made and designed for this purpose by Rossi Eugenio-Firenze, an artisan of Florence Italy. This trophy is to be competed for annually by yachts of the Club Handicap Fleet and awarded to the yacht with the highest overall score for the year.

The Board of Directors of SBYC may amend the conditions of this Deed as necessary to meet the changing needs of the racing fleets.

It is suggested that:

- 1. The races be conducted by a scoring system currently acceptable to the Board of Directors for that year.
- 2. Rather than being a marathon of endurance, that there shall be a fifty percent throwaway.
- 3. Safety rules and equipment be firm and be periodically updated by the Sail Policy Committee or the Board of Directors.
- 4. The name of the winning boat, and name or names of owners to be engraved annually on said trophy.
- 5. The trophy itself is to remain in the possession and custody of the Santa Barbara Yacht Club.
